

Requirements For Award

1. **ONLY ONE CERTIFICATE WILL BE ISSUED PER PROPERTY:**
For example, a descendant may not receive another certificate if a former owner or relative has already received a certificate for the same property.
2. **CONTINUOUS FAMILY OWNERSHIP OF PROPERTY FOR 150 YEARS:** The farm must have been in continuous family ownership. Title of the sesquicentennial property today must reside in a blood relative of the original owner, or a legally adopted child of a descendant. An abstract of title is the best evidence of continuous family ownership. Please do not send valuable documents to our office; copies are sufficient.
3. Please provide a short write-up about your farm.
4. Please provide 5-10 pictures of your farm through the years

RECOGNITION: Farms with 150 years or more of continuous ownership through the year **2021**, will be recognized at the Annual Farm City Dinner on **March 11th 2021** and throughout the year at various events. Farms also have the opportunity to be recognized at a special program during the Wisconsin State Fair if they so desire.
