

2021 Century Farm Requirements For Award

1. **ONLY ONE CERTIFICATE WILL BE ISSUED PER PROPERTY:**
For example, a descendant may not receive another certificate if a former owner or relative has already received a certificate for the same property.
2. **CONTINUOUS FAMILY OWNERSHIP OF PROPERTY FOR 100 YEARS:** The farm must have been in continuous family ownership. Title of the Century property today must reside in a blood relative of the original owner, or a legally adopted child of a descendant. An abstract of title is the best evidence of continuous family ownership. Please do not send valuable documents to our office; copies are sufficient.
3. Please provide a short write-up about your farm.
4. Please provide 5-10 pictures of your farm through the years

RECOGNITION: Farms with 100 years or more of continuous ownership through the year 2023, will be recognized at the Annual Farm City Dinner on March 12rd, 2023 and throughout the year at various events. Farms also have the opportunity to be recognized at a special program during the Wisconsin State Fair if they so desire.
